Transport Fee: (VAT charges if applicable)

BD 28 per month which is chargeable term wise (except for the month of July and August) and is non-refundable.

Looking at the lesser number of working days in March due to the Annual Exam, some parents ask for the discontinuation of school transport and a refund of the bus fee for March. As the



annual contract with the transport company does not allow such arrangements and the school has to pay the full amount for the month of March as well, we urge the parents not to make such requests and to cooperate with the school.

Transport fees for grades X and XII students are not accepted in the month in which the students write their Board papers at the exam center in another school. The same once remitted will not be refunded.

Scholarship for Grade XI 2025-2026:

Based on CBSE Board examination results of Grade X, Scholarship is available from second term onwards, as per the details given below.

- 1. School Topper will be eligible for 75% Scholarship.
- 2. The Students securing 95% and above will be eligible for 50% scholarship. (*)
- The Students securing 90% and above but less than 95% will be eligible for 25% scholarship. (*)
- To avail the scholarship benefit in Grade XII, the student has to maintain an aggregate of minimum 75% in Grade XI.
- (*) Only the exact marks scored in the board examination will be considered for scholarship. **No rounding off is applicable.**

NOTE:

- Scholarships are not available for TC cases. If a parent applies for TC of her/his ward(s), who is availing scholarship then the TC will be issued only after full term fees is cleared in actual amount as mentioned in the term fees table.
- To avail the scholarship scheme, a parent must apply in the office along with a copy of the Board mark sheet.
- 3. The last date for applying for a scholarship is 15th September 2025.
- 4. We will not be able to consider any application submitted after 15th September 2025.

Guidelines related to Student Leave (Absenteeism)/Transfer Certificate:

- Leave application should be filled, in advance, online through the Parents ID along with medical/ fitness certificates and the same should be communicated through the school portal to the HRT.
- Applications related to long leave, transfer certificate and change of bus stop must be submitted in the original.
- Applications for any requirement from school should reach well in advance and no such applications including TC will be processed during summer vacation or winter break. (Please refer Page 18)
- As per Ministry guidelines, if a child is absent for 10 or more consecutive days, the school needs to inform Ministry of Education (Private Education Directorate).
- Annual examination is compulsory for promotion to the next grade.
- If the student is absent for any assessment, he/she will not be eligible for academic awards in the current session.
- The parents are expected to take the responsibility of covering up the portions, missed during this leave period.
